#### K.3 Rosie MacLennan

Regional Chair Emmerson noted that earlier this month, two-time Olympic trampoline champion Rosie MacLennan announced her retirement. The Township of King resident represented Canada at four Summer Olympic Games and made history in 2016 when she became the first trampolinist to ever win back-to-back Olympic gold medals.

Rosie's career includes three world championships, two gold medals as the Pan American games, and six gold medals at the Pan American trampoline championships. Rosie has also been a champion for females in sport, advocating for greater opportunities for girls and women to pursue a career in professional sports.

On behalf of Council and York Region residents, Regional Chair Emmerson congratulated Rosie on an outstanding athletic career and wished her all the best in her future efforts.

# The Need: Sex Trafficking in Canada, and Ontario

- Sex trafficking is defined as recruiting, moving, or holding victims to exploit them for profit.
   Traffickers control and pressure victims by force or through threats, including mental/emotional abuse & manipulation.
- Sex trafficking as an international illegal enterprise is growing and is second only to guns and drugs
- A gun or drugs can be sold only once a girl can be sold for sex many times each day
- Over 90% of people trafficked in Canada are Canadian citizens. Over 60% are residents of Ontario. Anyone can be trafficked with racialized groups overrepresented
- Over 60% of prosecuted trafficking cases derive from the GTA
- Children are targets for trafficking, with an average age of entry as low as 11 to 16 years of age
- One girl represents tens of thousands of dollars in revenue to a trafficker on a given year, and each survivor can cost the social services and justice system hundreds of thousands of dollars
- The severe trauma resulting from physical and emotional abuse, substance dependence used as a form of control, lack of medical care, and at times outright torture, leave survivors with complex, unique needs that are unlike any other



### The Need: Sex Trafficking in York Region

- Instances of sex trafficking are increasing within York Region, with approximately 146 to 185 survivors served in the Region annually
- Survivors are mostly female, ranging in age from 11 30+
- Survivors can be trafficked for months or years, with 10 years as an approximate duration
- Over 90% of survivors in York Region are residents of Ontario
  - Over half of survivors in York Region are residents of the Region



### Current Response to the Need in York Region

- There are 8 shelters in York Region survivors could access, however shelters are generally not equipped to meet the unique needs of survivors of sex trafficking
- There are 6 beds specifically for survivors of sex trafficking in York Region, provided by 360°kids
- There is no available crisis\* housing for survivors in York Region, nor is there any dedicated housing with on-site unique supports for survivors with children and for survivors that are older than 26

Total York Region Supported Beds	6
Crisis Beds	0
Stage 1 (length of stay is up to 1 year)	3
Stage 2 (length of stay is up to 2 years)	3

\*Crisis = somewhere safe & supported for survivor to go immediately upon exiting from trafficker – no applications/forms required

This response is not adequate: There is a critical need for dedicated housing for survivors of sex trafficking in York Region, especially for survivors beyond their youth and those with children




### **Proposed Solution For This Urgent Need**

- Purpose-built safe house and hub with 24/7 professional and lived experience staff, low barrier entry
- A continuum of unique care to treat severe PTSD, medical issues, emotional abuse, and harm reduction approach to substance abuse

#### Safe House and Serve Hub Specifics in Brief:

- 2 identical pods housing 6 survivors each with accommodation for wheelchair accessibility and some rooms large enough for a cot or crib for survivor's children
- 3 crisis beds separate from main living pods
- Space for counselling, fitness, plant therapy, flex activities, classrooms
- Service hub for initial and ongoing care / navigation (health, education, legal)





### Cost and Benefits of a Safe House and Hub

#### Cost

Capital: \$19 million - includes land, preconstruction planning & construction

Annual Operating: \$2 million

#### **Benefits**

- Young women who have been controlled, sold and harmed emotionally and physically for the financial benefit of others are given the opportunity they fully deserve, to define their future and begin the journey to a safe, fulfilling independent life
- Inaction is costing our government: a study by the University of Winnipeg of personal, fiscal and societal costs of sexual exploitation (in today's dollars):
  - \$273,063 estimated lifetime personal cost for exploited individuals
  - \$734,309 estimated cost to social services & justice per individual
  - \$700,815 other societal costs per individual
  - \$1.7 m estimated total social costs and lost potential per exploited individual



### How Can You Help?

- The Project Team has identified a critical need for dedicated housing for survivors of sex trafficking in York Region, and established a project concept and path forward to address this gap
- The Project Team is requesting that York Region staff review the Business Plan, work with the Project Team to identify a site and funding sources, and report back to Council on the preferred approach to address the critical gaps identified in the Plan
- By partnering to create a purpose-built Safe House and Service Hub for survivors of sex trafficking, we can realize savings to our community worth millions of dollars a year and provide support that is clearly owing to those victimized by a crime society has not been able to address

# Our Process for Preparing the Business Case for a Safe House and Service Hub

Dear York Region Council,

We're hoping that you can clarify York Region Council's official position on the Ford government's passing of Bill 23.

Our concerns are on numerous fronts. As we understand it, Bill 23 removes long-standing protected areas within Ontario's Greenbelt for development, leading to greater urban sprawl, destruction of critical wetlands and our watershed, not to mention threats to wildlife and locally grown food. The provincial government's position is that this sacrifice is necessary to build "affordable homes"; however, if the government was truly interested in creating affordable housing, they would build on existing available land closer to the areas accessible to existing employment and transit. Instead an already scarce labour force will be drawn from real affordable housing projects to the more lucrative suburban developments outside of the city.

According to the February 8, 2022 Report of the Ontario Housing Affordability Task Force, "a shortage of land isn't the cause of the problem. Land is available, both inside the existing built-up areas and on undeveloped land outside greenbelts".

Secondly — and we would think of grave concern to York Region Council — this Bill removes development charges that municipalities depend upon when providing services to new residential areas. The Ford government argues that this reduction only applies to "affordable homes", but 80% of a \$1.2 million home is not what most would consider "affordable".

As the Mayor of Aurora, Tom Mrakas, said:

Bill 23 effectively guts many of the legislative mechanisms we rely upon as a municipality to fund our infrastructure needs, plan future parks and amenities, protect our natural and built heritage, and plan for growth and development. With the proposals in Bill 23, the Minister will have the power to amend municipal Official Plans, at any time, for any reason, and without public consultation (AMO).

We believe that many Vaughan residents, will be shocked and outraged, as we were, to learn from yesterday's CBC news story that Vaughan estimates a property tax increase of 75 - 80% to cover the shortfall.

In addition, the omnibus Bill 23 is "proposing sweeping changes to the province's natural heritage and land use planning legislation and policy." It erodes "environmental protections and excludes the public from meaningful involvement in land use planning and decisions affecting their communities" (Ontario Nature, November 7, 2022). This undemocratic bill removes the requirement for public meetings for draft plans of subdivision and limits third-party appeals at the Ontario Land Tribunal for official plan amendments, zoning bylaw amendments, and minor variances and consents. This destabilizes the current democratic process and essentially curtails community voice.

Additionally, Bill 23 undermines **cultural heritage protection** by "forcing communities to drop properties from their heritage registers if they are not designated in two years and requiring that

the standard for designation of properties be hiked from at least one of Ontario's heritage criteria to two" (Diane Chin, Architectural Conservancy Ontario's chair):

Most critically, Bill 23 will **undermine environmental protection and climate change** mitigation. It will limit the role of conservation authorities to solely flooding and erosion hazards. Currently, the role of conservation authorities is complex and varied (e.g., watershed planning/management, coordinated flood protection, conservation of green lands and biodiversity). Removing 7400 acres of protected, precious green space and farmland in the Greenbelt will not solve the housing crisis; especially for those who most need affordable housing. It will, however, destabilize the intricate ecosystems of farmlands, woodlands, rivers, streams and wetlands. Of particular concern is the drastic amendments to the Ontario Wetland Evaluation System, ensuring that very few wetlands in Ontario will be deemed provincially significant and protected from development.

Last but not least, the Chiefs of Ontario are opposed to Bill 23 because they were **not consulted** with the removal of sections of the Greenbelt within their traditional territories: The Chiefs of Ontario express their full support for First Nations Leadership in their opposition to Bill 23: More Homes Built Faster Act due to its clear violation of First Nations constitutionally protected, inherent and Treaty rights and its inevitable adverse environmental impacts on First Nations ancestral and traditional territories. The Government of Ontario's tabling of Bill 23 is a blatant violation of First Nations' inherent, domestic, and international rights over their ancestral and traditional territories, according to Ontario Regional Chief Glen Hare.


These are just a few of the reasons why Council may have noticed a rapidly growing number of its usually quiet citizens, like us, speaking out, signing petitions, protesting and putting up signs of opposition. We individual citizens are joined by a coalition of groups including environmentalists, labour unions, farmers, housing advocates, past mayors, municipalities, architects and many others in opposing both Bill 23 and the Premier's plan to open up sections of the long-protected Greenbelt for housing development.

As I trust you'll agree, the Greenbelt must be protected for current and future generations of all Ontarians, and I hope we can count on York Region Council to join the public's opposition to Bill 23.

Re: 2030 Commonwealth Games

On January 12, 2023, Council received an intention that a notice of motion regarding bidding to host the 2030 Commonwealth Games would be brought forward to Council. This memo and attachment provide information on the 2030 Commonwealth Games and the bid selection process.

### Commonwealth Games is an international multi-sport event among athletes from the Commonwealth of Nations

The Commonwealth of Nations, simply referred to as the Commonwealth, is a political association of countries and member states, the vast majority of which are former territories of the British Empire. The 2030 Commonwealth Games, officially known as the XXIV Commonwealth Games will mark the centenary of the Games, first held as the British Empire Games, and hosted by the City of Hamilton in 1930.

The Commonwealth Games are overseen by the <u>Commonwealth Games Federation</u> (CGF), an international body which controls the sporting program and selects the host city from among a select few international bidders that have been chosen by a country's overseeing sporting body.

Commonwealth Sport Canada is the Canadian sporting body that selects which municipality (or group of municipalities) would best represent Canada to host the Commonwealth Games. Canadian municipalities looking to bid on hosting the Commonwealth Games would first send a bid into Commonwealth Sport Canada, which would in turn chose the best municipality to represent Canada in a larger international bid to the Commonwealth Games Federation. It is anticipated the host city for the 2030 Commonwealth Games will be chosen by the Commonwealth Games Federation in November 2023.

### Victoria, Australia has allocated \$2.6 billon to deliver 2026 Commonwealth Games

In January 2022 the Victorian State Government announced it was giving consideration to a late request from the Commonwealth Games Federation (CGF) to host the Games. On February 16, 2022, the Premier of Victoria Daniel Andrews confirmed the state was in exclusive negotiations with the CGF to host the 2026 Commonwealth Games. It was stated that if successful in hosting the Games this second time, Victoria would aim to use the state's regional centres and existing infrastructure to control costs. This bid was confirmed as successful by the CGF on April 12, 2022.

In May 2022 the Victorian State Government allocated \$2.6 billion to deliver the 2026 Commonwealth Games. This money is being used to build housing, infrastructure, and athlete hubs in each of four regional sites, as well as provide for enhanced security and transportation needs that will result from an event of this size.

# Hamilton has been selected by Commonwealth Sport Canada as Canada's candidate host city for the 2030 Commonwealth Games contingent on receiving support from the three levels of governments

Commonwealth Sport Canada's (CSC) process to select Canada's 2030 Commonwealth Games candidate host city took place in 2020 with two cities, the City of Calgary, and the City of Hamilton both entering a bid at that time. The City of Hamilton's bid includes partnerships with adjacent municipalities in Halton, Waterloo and Niagara Regions as well as endorsements from the City of Mississauga, the City of Toronto, and indigenous communities of the Six Nations of the Grand River and the Mississaugas of the New Credit.

This 2030 bid coincides with the 100th anniversary of the first Commonwealth Games held in Hamilton in 1930; then know as the British Empire Games. More information about Hamilton's 2030 Commonwealth Games intentions can be found at <a href="https://example.com/Hamilton2030.ca">Hamilton2030.ca</a>) Eid Corporation (hamilton2030.ca)

On June 17, 2020, CSC confirmed to those leading Hamilton's bid (Hamilton 100Bid Corporation) that Hamilton has been selected as Canada's candidate for the 2030 Commonwealth Games (Attachment 1). This selection is contingent upon Hamilton100 receiving support from the three levels of governments. CSC has committed to assisting with securing this support from all levels of government. There have been commitments from both the federal government and the City of Hamilton in support of advancing this bid to the international level, contingent upon a similar commitment of support from the Province of Ontario.

At the time of this memo, the Province of Ontario has not committed to supporting this bid. CSC has set a January 31, 2023, deadline for confirmation of commitment from the Province of Ontario. Should the Province not provide confirmation of commitment by January 31, CSC has indicated they would be open to alternative bids that would most likely favour cities outside of Ontario.

### York Region's domestic bid to potentially host the 2014 Commonwealth Games was estimated to cost \$800,000

In 2005 York Region submitted a letter of interest to the Commonwealth Games Association of Canada (CGC) to be considered as the Canadian candidate to potentially host the 2014 Commonwealth Games. On September 22, 2005, Regional Council endorsed a 2014 Commonwealth Games Bid.

The report indicated the Commonwealth Games could have an estimated economic impact of over \$3.0 billion to the Region in the form of buildings and transportation infrastructure, along with subsequent business investment and visitor spending. The report also indicated the first phase of bidding to determine the Canadian candidate city ("Domestic" phase) would cost an estimated \$800,000. If successful at the domestic phase, the subsequent bid phase to select the ultimate host municipality from all international candidates ("International" phase) was estimated to cost another \$3.0 million.

York Region undertook development of a domestic bid and submitted this bid to the Commonwealth Games Association of Canada (CGC) by the required November 1, 2005, deadline. Only York Region, Halifax, Ottawa, and Hamilton submitted domestic bid proposals to be Canada's candidate to host the 2014 Commonwealth Games. Presentations from each bid municipality to the CGC were held on December 13, 2005, and two days later Halifax had been chosen by the CGC to be Canada's candidate city to potentially host the 2014 Commonwealth Games. Halifax subsequently withdrew from the next phase that involved international bidding, and on November 9, 2007, the 2014 Commonwealth Games was awarded to Glasgow, Scotland by the Commonwealth Games Federation General Assembly.

### Conclusion

Given that the City of Hamilton has already been previously endorsed by Commonwealth Sport Canada as Canada's 2030 Commonwealth Games candidate host city (conditional on the still outstanding Province of Ontario commitment), it is unclear whether the opportunity to enter a bid still exists at this time.

WHEREAS ongoing underfunding of Women's Support Network of York Region has reduced the number of resources available to provide these services due to highly specialized skill requirements that are unmatched by low wages and benefits relative to other mental health funded positions; and,

WHEREAS the current COVID-19 pandemic has resulted in increased people in the community requiring the services of Women's Support Network of York Region; and,

WHEREAS sexual violence disproportionately impacts our community's most vulnerable members including women and girls, trans, and non-binary people, people with disabilities, and people who identify as Black, First Nations, Metis, Indigenous, racialized, and/or 2SLGBTQIA+1;

THEREFORE BE IT RESOLVED THAT increased and sustainable provincial funding for Women's Support Network of York Region funding and other community-based sexual assault centres be supported for priority consideration by the Provincial Government and its agencies.

AND WHEREAS the sum set out in Column 2 of the schedule opposite each lowertier municipality set out in Column 1 of the schedule does not exceed fifty percent (50%) of the levy made by Regional Council against such lower-tier municipality in the year 2022;

1. Each specific sum set out in Column 2 of the schedule set out in this section is hereby levied for the year 2023 for the purposes of the Region against the lower-tier municipality set out opposite such sum in Column 1 of the schedule.
