Item D.3 - Impacts of Development Charge Reductions and Mechanisms to Increase Housing Affordability in York Region

The Building Industry and Land Development Association is in receipt of Item D.3 – *Impacts of Development Charge Reductions and Mechanisms to Increase Housing Affordability in York Region* as part of the April 3<sup>rd</sup> Special Regional Council agenda.

At this meeting, staff are seeking Council's endorsement of the proposed recommendations. If approved, staff will present their final recommendations for adoption before Council's summer recess. BILD supports the proposed approach and, following Council endorsement, looks forward to continued consultations with staff on the implementation details, some of which are expected to be included in the report being brought forward prior to summer recess. On behalf of our York Forum, we commend York Region for its leadership in addressing the pressing challenges facing the housing industry and for proactively exploring solutions that benefit both builders and homebuyers.

Our housing crisis continues to place unprecedented pressure on the industry, making it increasingly difficult to build and sell homes. Adding to these challenges, the ongoing U.S.-Canada trade dispute is creating further economic uncertainty and shaking consumer confidence in the housing market.

The urgency of the situation in York Region is clear. High-rise sales have plummeted by 95% compared to the 10-year average, while low-rise sales have fallen by 67% over the same period. These stark declines underscore the critical need for government action to support the industry and rebuild consumer confidence. In February 2025, only 123 new homes were sold in the region—far below the typical 600 homes sold during this month.

We appreciate the efforts of Regional staff for setting out a process and policy areas that aim to alleviate the financial pressures on housing development and create an environment where new homes can be delivered more efficiently. The initiatives under consideration demonstrate a commitment to housing affordability and supply, and we welcome the opportunity to collaborate on actionable solutions.

Our members are not just building homes—they are shaping communities. We remain committed to ensuring that York Region continues to be a place where families, first-time buyers, and renters can find housing that meets their needs. This is not just about supporting



the industry; it is about ensuring the Region remains a place where people can afford to live, work, and thrive.

We appreciate the opportunity to provide this correspondence and reaffirm our commitment to working closely with York Region to advance meaningful, actionable solutions. BILD looks forward to continued collaboration with Regional staff and Council during this critical time to support housing affordability and supply.
