
Private housing market pressures

- York Region has the lowest proportion of purpose-built rental housing in the Greater Toronto Area
- In 2019:
 - Vacancy rate was 1.2%
 - Average resale price rose above \$940,000

Growing demand for subsidized housing

- In 2019, York Region's wait list reached 17,457 households, an 8% increase from 2018
- 245 households housed, 125 within HYI's portfolio
