Sewage, Water and Stormwater	Additional direction on assessment of long-term impacts of individual on-site sewage and water services on environmental health of the rural settlement areas
Sewage, Water and Stormwater	Additional direction and criteria on extension of partial servicing into rural areas.
Sewage, Water and Stormwater	Additional criteria for stormwater management including preparing for the impacts of a changing climate.
Agriculture	Policy encouraging municipalities to use an agricultural systems approach to enhance continuity of agricultural land. This includes additional definitions for "agricultural system" and "agri-food network".
Human-made hazards	Addition of a policy to support re-use of excess soil in planning and development approvals.
Implementation and Interpretation	Relocation of many interpretation policies to the Preamble.
