Re: Proposed *Our King* Official Plan 2019 ("*Our King*") Approval by York Region

We are the solicitors for Westlin Farms, owner of the lands known municipally as 12470 Weston Road, King Township (the Subject Lands").

Our King, as modified and proposed for approval by York Region, identifies the Subject Lands as being subject to a site-specific deferral (Deferral 1).

By correspondence dated August 18, 2020 and in subsequent telephone discussions, you advised that Deferral 1 could be removed from *Our King* once our client resolved its outstanding Regional appeals and site-specific applications regarding the Subject Lands. I attach copies of letters withdrawing my clients appeal of the 2010 York Region Official Plan (YROP 2010) and discontinuing its application for a Regional Official Plan Amendment to facilitate the development of a private 9-hole golf course on the Subject Lands (ROPA 69).

As the YROP 2010 appeal and the ROPA 69 application represent all outstanding Regional matters regarding the Subject Lands, we trust that staff will now recommend to Regional Council that Deferral 1 be removed from *Our King* prior to its approval.
