## RE: King; Engineering, Public Works & Building Department Report EPWB-2020-10 Preferred Timing for Blue Box Transition to Producer Responsibility

At its meeting of May 4, 2020, Council received and supported the recommendations in Engineering, Public Works and Building Department Report Number EPWB-2020-10, a copy of which is attached for your information and file, with respect to the preferred non-binding timing for the transition of the Blue Box program to full producer responsibility and approved the following recommendations, as amended:

- a) THAT the report titled "Preferred Timing for Blue Box Transition to Producer Responsibility" (EPWB-2020-10) dated May 4, 2020 be received; and
- b) THAT Council approve the timing for transition of the Blue Box Program to full producer responsibility for collection on December 31, 2025 coinciding with the end of the current waste collection contract; and
- c) THAT Council authorize staff to continue working in cooperation with the Northern Six (N6) municipalities in providing Blue Box collection services on behalf of producers, through future long term collection contracts, subject to mutually agreeable financial and operational terms; and
- d) THAT Council authorize staff to communicate this resolution to the Association of Municipalities of Ontario (AMO), to Jeff Yurek, Minister of the Environment, Conservation and Parks, Caroline Mulroney, MPP for York-Simcoe, Stephen Lecce, MPP for King-Vaughan, and the Regional Municipality of York.
