Dear Regional Council Members of York, my name is Bruno Malfara and I'm a concern resident of Kleinburg, Ontario. I would like this letter to form part of the official minutes for the council meeting on March 18, 2021 – Let it be noted I'm in opposition to the construction of the Highway 413

I'm writing to you to once again to ask you to reverse your support for the proposed 413. I'm also asking that you bring forth a motion to support a Federal EA. I would also like you to withdraw support for the Bradford Bypass

The proposed 413 will have a negative impact on Vaughan and neighboring municipalities

- Destruction of prime farm land
- Destruction of very sensitive greenbelt
- Destruction of wildlife that call the wetlands and greenbelt home
- The polluting of our drinking water
- Damaging to the natural flood controls
- It will create more traffic Induced demand
- You will create more urban sprawl
- This is a Highway to nowhere and will cause gridlock at the entry and exit points
- The real Highway Costs will be astronomical (see attached)

Folks, the Regions of Peel, Halton Hills, The City of Mississauga, City of Toronto, City of Vaughan have all agreed not to support the 413. You should also withdraw your support for the 413. To the Vaughan Regional councilors, this road will not benefit the citizens of Vaughan it will only benefit a few developers. Focusing on cost (see below) The Provincial government would like us to believe that the overall cost of constructing the 413 is \$6 Billion dollars. Folks this is not true, please see below an estimate (As you can appreciate the author of this estimate works within the infrastructure industry and for obvious reasons cannot be named)

We also had a second source provide costing and it was estimated at almost \$13 Billion.

A third from, a professional, who works for a major infrastructure engineering firm; he said it would be more than \$16 billion dollars

Folks this is a long way from the \$6 Billion the province has budgeted. With such a vast difference in cost I believe it is your responsibility as our elected officials to question the spend. Please perform your fiduciary duty / your responsibility and ask for an independent / non biased third party to analyze and prepare an independent cost summary. I'm very confident the third party quantity surveyor / estimators will be very close to the costing provided above. The citizens / taxpayers of York Region deserve to know. How can you support such a project without truly knowing the cost? Cost that will be placed on taxpayers shoulders!!! Please take a moment and think how else \$16 billion can be spend to provide immediate traffic relief?
