Subject: A human being is more than a beating heart

Thank you for taking the time today to hear my concerns. This is a very very dark time for me and my family and I implore you as public representatives for the people to really examine the history of your role in caring for the community and consider very prayerfully what has been laid on your conscience as these measures continue to induce hard times for all.

Let me just open by saying that the health of a community is not just determined by the number of hearts that are beating. Secondly, of course, we all know by now that lockdowns decrease beating heart numbers as well.

1. York Region Public Health confirmed with me via email that there is no OBJECTIVE definition of a Public Health Emergency using an infection fatality rate, excess death or other, this is absolutely unacceptable as there cannot be a determination of a beginning or an end of a health emergency without an objective definition.
2. A Meta analysis systematic review of 64 studies published in January 2021 showed WITHIN HOUSEHOLD (ie. No measures) SARs CoV 2 was transmitted 200 out of 1000 times (18%) by a SYMPTOMATIC person. And 0.7% of the time by an asymptomatic or presymptomatic person WITHIN a household (ie. No measures).

This continues to confirm that healthy people do not spread disease.

3. There has been no documented transmission of child to teacher transmission in the whole world. This was stated by an Irish Paediatric immunologist on his review of the research. And negligible child to adult transmission especially under the age of 10. Yet you continue to endorse masking and not speaking in school without a mask on, no playing outside without a mask and so on and so on and so on with no end. As a result, I had to pull my children from public school fully for their own mental health as I personally work as hard as I can to provide a quality education for my children at home.
4. Thirdly, on the Ontario Public Health website the PCR testing protocol remains unchanged since September 2020 even though the WHO even said that the PCR test should not be cycled more than 28 times. And Ontario has it up to 45 CT. On top of that gross mistake, there is no follow up testing with a respiratory panel test to determine the difference between a Rhino virus, Influenza, and Coronavirus etc. So there continues to be a gross false result using the PCR tests as the sandy foundation of emotions and measures.
5. Fourth and most importantly, you are not the Power of Attorney for the people of Ontario. We are a free democracy and to maintain such our Constitution needs to be held in very high regard. The more public health forces, coerces and mandates the lesser and lesser degree of compliance and trust they will have with the public. That was stated by the former Chief Medical Officer of Ontario who himself has been censored...imagine that.

6. Fifthly the advertisement of experimental vaccines when long term outcomes have not been tested and peer reviewed from companies that hold no liability whatsoever and have a criminal background is grounds for a second Nuremburg trial as it is illegal to coerce or force a human being to participate in an experiment. And this is openly an experiment under 'Emergency Use Authorisation'. Again without an objective definition of 'emergency'.
7. There are therapeutics that are available and unannounced to the public that show to have 80% better outcomes in hospitalised patients and prove safe for EARLY treatment. Not stay at home till your really short of breath 'treatment'.

Many have died under lockdown measures. "The most restrictive lockdown measures in North America" have caused numerous deaths, societal and economic devastation. How does that weigh on your conscience? Do you feel anything at all? This is the time to stand up for your fellow man, for your weaker brother and help them up.
