RE: Traffic Safety on Aurora Road

Please be advised the above-noted matter was placed before Council at its meeting held on August 24, 2021 and the following motion was passed:

WHEREAS the safety of Whitchurch-Stouffville residents, including motorists, cyclists and pedestrians, is of primary importance; and

WHEREAS Aurora Road (Regional Road 15), from Highway 48 to Ninth Line, is a Regional road under the jurisdiction of York Region; and

WHEREAS speed limits for this segment of Aurora Road are within the jurisdiction of York Region and managed through an associated Regional By-law; and

WHEREAS traffic controls for Regional intersections, such as traffic signals and roundabouts, are within the jurisdiction of York Region; and

WHEREAS several recent traffic accidents of high severity have taken place at the intersection of Aurora Road and Ninth Line; and

WHEREAS residents of Whitchurch-Stouffville have raised concerns regarding the excessive speed of vehicles on Aurora Road between Highway 48 and Ninth Line; and

WHEREAS appropriate intersection control improvements and speed limit reductions serve to decrease the likelihood and severity of traffic accidents.

NOW THEREFORE BE IT RESOLVED THAT the Town of Whitchurch-Stouffville request that York Region enact Regional By-law amendments that reduce speed limits on Aurora Road as follows:

- 60km/hr reduced to 50km/hr, from Highway 48 to just east of Ballantrae Public School; and
- 70km/hr reduced to 60km/hr, from just east of Ballantrae Public School to Ninth Line; and
