K.1 Declaration of Office - Mayor David West

K.3 Special Shareholder Meeting - York Region Rapid Transit Corporation

Regional Chair Emmerson advised that a special shareholder meeting of the York Region Rapid Transit Corporation would be scheduled to confirm an additional seat on the Board, allowing the appointment of Mayor West.

K.4 Housing Affordability Task Force Membership

Regional Chair Emmerson announced the appointment of Mayor David West to the Housing Affordability Task Force in place of former Acting Mayor Joe DiPaola.

K.5 Regional Council Special Meeting - Yonge North Subway Extension Alignment

Regional Chair Emmerson reminded Council Members of the Regional Council Special Meeting on February 3, 2022 beginning at 9 a.m. regarding the Yonge North Subway Extension alignment.

K.6 Forbes Annual List of Canada's Top Employers

Regional Chair Emmerson advised that The Regional Municipality of York has once again been named on the Forbes list of Canada's Best Employers. York Region was recognized as the highest-ranking government employer in Canada and fourth overall among 300 organizations.

K.7 Lincoln Alexander Day

Regional Chair Emmerson noted that January 21, 2022 was Lincoln Alexander Day. As Canada's first Black Member of Parliament, Cabinet Minister and Lieutenant-Governor of Ontario, Lincoln Alexander had a long and distinguished career in public service.

Regional Chair Emmerson recognized February as Black History Month and encouraged everyone to learn more about black history and the many contributions of black Canadians to the settlement, growth and development of various communities.

K.9 Bell Let's Talk Day

Regional Chair Emmerson advised that January 26th was Bell Let's Talk Day - a day to engage staff and York Region communities in meaningful conversations about mental health.

Regional Chair Emmerson noted that today is International Holocaust Remembrance Day, which serves as a driver to building inclusive and welcoming communities around the world and an opportunity to remember the victims, survivors and heroes of the holocaust.
