G.1 Update on Accessibility Activities

Lois Davies, Manager, Social Policy and Accessibility, Strategies and Partnerships Branch, Community and Health Services provided updates as follows:

G.1.1 Transportation Master Plan Focus Group

G.1.2 Single-Use Items Focus Group

Environmental Services staff will hold virtual focus groups on various dates and is seeking input from committee members regarding potential barriers of the voluntary single-use reduction strategy.

G.1.3 York Region Accessibility Advisory Committee 2022 Recruitment

The current four-year term of the York Region Accessibility Advisory Committee will be coming to an end in September. Members may serve for a maximum of two consecutive terms, after which they must take a break of at least one four-year term before re-applying. Members who have served for one term and wish to continue are not required to reapply.
