**RE: King Township
Resolution –
Installation of Traffic Signals on the 15th Sideroad
– Township Wide Recreation Centre 1600 15th Sideroad**

At its meeting of June 27, 2022, Council received and supported the following recommendations, in Community Services Department – Facilities Division Report Number COM-REC-2022-002 with respect to King’s new Township Wide Recreation Centre and adoption of the following Resolution:

1. Report Number COM-FAC-2022-002 be received; and
2. Council authorize an increase to the project budget to \$86,000,000 to be funded by Development Charges and Reserve funds from Growth and Infrastructure to be repaid with proceeds or other funding; and
3. Project 05-9717 for the Town Wide Recreation Centre (TWRC) budget be increased by \$10,150,910 funded by Developer Charges and a temporary funding strategy from the Township Reserve Funds; and
4. JR Certus Construction Company Limited being the lowest compliant bidder (Tender 2022-T14) with a total bid in the amount of \$73,206,565 (excluding HST) be awarded the contract for the construction of the Township Wide Recreation Centre; and
5. Council enact By-Law 2022-051, being a By-Law to authorize the Mayor and Clerk to award a contract for the construction of the Township Wide Recreation Centre, at this evening’s meeting of Council; and
6. Council adopt the following Resolution regarding the installation of Traffic Signals on the 15th Sideroad at the entrance to the parking lot at the Township Wide Recreation Centre at 1600 15th Sideroad and submit this Resolution to Regional Council for consideration:

“WHEREAS the Township and its consultants have identified a traffic signal is recommended at this location due to anticipated future traffic movements; and

WHEREAS studies have identified that the intersection will not satisfy the minimum criteria required by the York Region’s Traffic Signal Policy; and

WHEREAS York Region requires the cost of any unwarranted Traffic Signal to be paid by the local municipality;

NOW THEREFORE BE IT RECOMMENDED that the Township of King forward the adopted resolution to York Region to request that Traffic Signals be approved for future installation at the entrance to the Township Wide Recreation Centre at 1600 15th Sideroad”.
