BYLAW NO. 2023-06

A bylaw to establish the Tax Levy Development Reserve Fund

WHEREAS Regional Council has determined that a reserve fund be established to offset annual development charge collection shortfalls due to statutory discounts and exemptions by funding the tax-levy portion of development charge related phase-ins, discounts, and exemptions;

The Council of The Regional Municipality of York hereby enacts as follows:

- 1. A reserve fund to be known as the Tax Levy Development Reserve Fund is hereby established.
- 2. The Tax Levy Development Reserve Fund shall be operated and maintained from:
 - a. appropriations made from time to time from the current estimates of the Region;
 - the allocation from such sources of revenue as may be determined by Regional Council; and
 - c. the earnings derived from the investment of monies held in the reserve fund.
- 3. The Tax Levy Development Reserve Fund shall be used to fund the tax-levy portion of development charge related phase-ins, discounts, and exemptions.
- 4. Interest shall accrue on the balance outstanding in the Tax Levy Development Reserve Fund in accordance with investment policies approved by Regional Council.
