#### **2022 Disposal of Surplus Assets**

#### 1. Recommendation

Council receive this report for information.

## 2. Summary

This report advises Council of the disposal of surplus tangible capital assets, excluding land, buildings, and furniture from January 1, 2022, to December 31, 2022.

Pursuant to the <u>Disposal of Surplus Assets Policy</u> ('the policy'), a report shall be submitted to Council annually to advise of the disposal of surplus assets.

#### **Key Points:**

- This report identifies 63 surplus assets disposed of in 2022, in accordance with the Disposal of Surplus Assets Policy, excluding any disposed assets which expensed and not capitalized in the Region's Tangible Capital Asset Register:
  - 31 cars and light duty vehicles (includes sport utility vehicles)
  - o 32 buses

#### 3. Background

# The Disposal of Surplus Assets Policy ensures the recovery of the maximum residual value from surplus assets

Surplus assets refer to tangible capital assets that are obsolete, no longer needed, or no longer usable, as determined by the relevant Commissioner. The Disposal of Surplus Assets Policy is not applicable to the disposal of land, buildings, and furniture.

Disposals occur when the ownership of a Regional asset is relinquished by the department as a result of sale, destruction, loss or abandonment, resulting in the cost and accumulated amortization of the asset being reduced to zero.

The Director of the Procurement Office has delegated authority to approve the disposal of Regional surplus assets using a method to maximize their residual value.

# Staff follow prescribed methods for the disposal of surplus assets as defined in the Policy

Intention to dispose of surplus assets is collected from Regional departments as a requirement under public sector accounting standards, through the following methods, in the order listed below:

- 1. Trade-in the asset
- 2. Offer the asset free of charge to other Regional departments
- 3. Offer the asset at its net residual value to local area municipalities
- 4. Sell the asset through a competitive commercial mechanism, such as through a competitive bid or through auction, in an open and transparent process

Where applicable, assets may be disposed of through the Ontario Stewardship Program, a not-for-profit organization, whose primary objective is to keep materials out of landfills and to recover as much value as possible from assets at the end of their useful life.

If the above methods of disposal are unsuccessful or deemed inappropriate, the Procurement Office, in consultation with the relevant Regional department, will determine the most appropriate method of disposal in an environmentally sustainable manner.

If the asset is of a nominal value, it may be donated for charitable or benevolent purposes, at the discretion of the relevant Commissioner.

# Proceeds from the disposal of surplus assets are transferred in full to departmental asset replacement reserves

As outlined by the policy, proceeds from the disposal of surplus assets are transferred to the appropriate asset replacement reserve, as determined by the Commissioner of Finance.

### 4. Analysis

## Disposals in 2022 generated net proceeds of \$625,024

The total value of surplus assets disposed of in 2022, and their related proceeds, are identified in Table 1. These proceeds were transferred in full to the respective departmental Replace Reserve account.

The assets identified in this report were disposed of through auction. The majority of these assets reached the end of their useful lifecycle, with the remainder being substantially towards the end of their lifecycle.

Additional information regarding the specifics of each disposed of asset is available in Attachment 1.

#### 5. Financial

Proceeds of \$625,024 from the disposal of surplus assets were transferred in full to the respective departmental asset replacement reserves.

Upon disposal, the assets and any remaining net book value (historical cost less amortization) are removed from the Region's balance sheet.

An accounting gain of \$604,015 has been included in the 2022 financial statements as the proceeds of disposition were higher than the net book value of the disposed assets.

## 6. Local Impact

There is no local municipal impact associated with this report. No local municipalities expressed an interest in acquiring any of the assets identified in this report at their net residual value.

#### 7. Conclusion

The surplus assets identified in this report were disposed of in accordance with the Policy.

A total of \$625,024 in net proceeds was generated through the disposal of these surplus assets.
