
Report of the Chief Administrative Officer

Provincial Review of Regional Government – 2019 Summary & 2023 Preparedness

1. Recommendation

Council establish a Governance Task Force and approve an appropriate terms of reference once the Province formally announces a facilitator(s) for York Region.

2. Purpose

This report provides Council with a summary of York Region’s response to the 2019 Provincial governance review in preparation for the 2023 Provincial Regional Review announced in May 2023.

Key Points:

- York Region participated fully in the 2019 Provincial Governance Review
- Council established a Governance Task Force to guide the 2019 Provincial Governance Review
- York Region has demonstrated a strong commitment to working in partnership with Local Municipalities on service delivery and finding efficiencies – a practice encouraged by elected representatives of local Councils forming Regional Council
- York Region has a culture based on continuous improvement

3. Background

York Region actively participated in the 2019 Provincial Governance Review

On [January 15, 2019](#), the Province announced a review of regional governments with a mandate to assess whether the current groupings of regional and municipal governments are working efficiently

and effectively. The Province tasked two special advisors, Michael Fenn and Ken Seiling, to conduct this review. This review was completed by September 2019 with recommendations focused on governance, decision-making and service delivery provided directly to the Province. To date, recommendations related to this work have not been released.

2019 Regional Governance Review focused on responding to specific questions

The mandate for the Province's [2019 Regional Governance Review](#) focused on a series of questions, including:

Questions on municipal governance and decision-making;

- a. Is the decision-making (mechanisms and priorities) of upper- and lower-tier municipalities efficiently aligned?
- b. Does the existing model support the capacity of the municipalities to make decisions efficiently?
- c. Are two-tier structures appropriate for all of these municipalities?
- d. Does the distribution of councillors represent the residents well?
- e. Do the ways that regional councillors/heads of council get elected/appointed to serve on regional council help to align lower- and upper-tier priorities?

Questions on municipal service delivery;

- a. Is there opportunity for more efficient allocation of various service responsibilities?
- b. Is there duplication of activities?
- c. Are there opportunities for cost savings?
- d. Are there barriers to making effective and responsive infrastructure and service delivery decisions?

Council established a Governance Task Force to participate in the review

At the Regional Council meeting on [February 28, 2019](#), Council approved the Terms of Reference for a Governance Task Force to address the review mandate set by the Province. The task force met on [March 21, 2019](#) and [April 18, 2019](#) and included Mayors from all nine local municipalities and the Regional Chairman.

On [May 16, 2019](#), Council approved a resolution that supported the current two-tier government as a means to deliver critical infrastructure and consistent service levels across all York Region communities. This resolution was shared with the Premier of Ontario, the Minister of Municipal Affairs and Housing, the Special Advisors, local MPPs, local municipal Councils and was made publicly available.

A majority (9 of 10) of affected municipalities passed resolutions in favour of maintaining the existing two-tier municipal government model within York Region (Appendix A). Partners felt that the two-tier structure aligned well with the Ontario government's priorities, both generally and as part of the regional government review, to reduce red tape, improve service delivery for citizens and create a competitive environment through economic opportunity and job creation.

Province announces dissolution of Peel Region by January 2025

On [May 18, 2023](#), the Province introduced the *Hazel McCallion Act* to dissolve the Regional Municipality of Peel and make the municipalities of Mississauga, Brampton and Caledon independent. On [June 8, 2023](#), the *Hazel McCallion Act* received Royal Assent.

[Bill 112](#), *Hazel McCallion Act (Peel Dissolution)*, 2023 states the following:

- Respect and support the effective administration of local governance.
- Recognize that municipalities should be empowered with the tools needed to plan for population growth, including the tools needed to build more housing options, and should work together fairly and in good partnership with neighbouring municipalities.
- Understand that safe communities and the delivery of effective frontline services are key pillars of local government, including by preserving frontline workers.
- Appreciate the importance of value for money and high-quality services delivered in an efficient manner for taxpayers.
- Acknowledge that where there are shared assets and services, municipalities should be treated in an equitable and fair manner whereby all residents, regardless of where they live, are respected and have access to excellent services.

On [July 5, 2023](#), the Province appointed the [Peel Transition Board](#) to oversee dissolution. Peel Region has committed to sharing information on their [public website](#) throughout this transformation.

York Region will be working closely with Peel Region throughout the transition to prevent service disruptions and protect contract and program relationships as reported to Council on [June 15, 2023](#).

Province announces intent to review Upper-Tier Government in 2023

On [May 18, 2023](#), the Province committed to assessing the upper-tier municipalities of Durham, Halton, Niagara, Simcoe, Waterloo and York by appointing Provincial facilitators.

At the Association of Municipalities of Ontario conference on [August 22, 2023](#), the Minister of Municipal Affairs and Housing announced that the Province intends to appoint regional facilitators in Durham, Halton, Niagara, Waterloo, York and Simcoe County by September 11, 2023. The Minister stated the facilitators will be tasked with assessing local governance structures to ensure they are

prepared to support future growth and meet the needs of residents, particularly building homes and housing-enabling infrastructure.

4. Analysis

York Region and Local Municipal partners have a successful history of complementary service delivery

For over 50 years, York Region has collaborated with local partners and all levels of government to provide residents with high-quality public services.

Table 1 lists the critical services provided to York Region residents seamlessly through the current two-tier government structure. York Region, as an upper tier municipality, provides cost-effective, quality services throughout all nine local municipalities, such as Children’s and Court Services, Housing, Long Term Care, Paramedic and Police Services, Public Health, Social Assistance, Public Transit, Water and Waste Treatment, to name a few.

York Region has partnered with some or all local municipalities in sharing services or joint procurements. Appendix B provides a snapshot (not an exhaustive list) of recent examples of shared procurements and collaborations between York Region and local municipalities. Most notably, the Northern Six (N6) municipalities have collaborated successfully in several service areas to realize cost savings and efficiencies.

Local Municipalities demonstrated fiscal responsibility by accountably delivering services directly to their residents and/or through shared service agreements and partnerships with other municipalities to realize efficiencies through economies of scale for cost effective delivery of services.

York Region demonstrates accountability and commitment to continuous improvement

As our communities continue to grow to more than 2 million residents by 2051, York Region welcomes the opportunity to work with the Government of Ontario and our nine cities and towns to consider the best mix of roles and responsibilities between upper and lower tier municipalities, particularly in delivering on housing pledges and ensuring the seamless delivery of cross-jurisdictional services.

York Region is proud to have a strong culture of continuous improvement and accountability. York Region’s record of delivering critical infrastructure and services to our communities and residents has served as a strength for the organization and will set the foundation for this most recent review of our two-tiered governance model. (Table 2)

While awaiting the announcement of a provincially appointed facilitator, York Region’s top priority remains the efficient delivery of 15 core programs and services that support the economic strength, social viability and overall well-being of our communities.

York Region has strengthened service delivery since 2019 review

The 2019 provincial review provided an opportunity to reflect on York Region and Local Municipal collaborations and identified opportunities to strengthen partnerships in some areas. Specific areas of desired improvement related to land use planning approvals have been subsequently addressed in provincial legislation. Regional staff have worked closely with local counterparts to improve on data communication for uninterrupted service delivery.

5. Financial Considerations

There are currently no financial impacts associated with this report. However, any future decisions on service delivery should, according to the Provincial Review mandate, be premised on improving efficiencies wherever possible.

6. Local Impact

The outcomes of service delivery discussions and the Provincial Review may result in changes to local and/or regional services.

7. Conclusion and Next Steps

York Region is committed to collaborating with local partners and all levels of government to provide residents with high-quality, cost-effective public services that respect our taxpayers. York Region is proud to have a strong culture of continuous improvement and accountability while delivering critical infrastructure and services to our communities and residents.

While awaiting the announcement of a provincially appointed facilitator, York Region's priority remains the efficient delivery of core programs and services that support the economic strength, social viability and overall well-being of our communities.

Staff will continue to monitor and assess the impacts of Peel Region’s dissolution on York Region.

Updates will be provided to Council as the Province releases further details on York Region’s facilitator(s), guidelines and mandate. Once the Province formally announces a facilitator(s) for York Region, it is recommended Council establish a Governance Task Force with appropriate terms of reference.


