Today this area is home to many diverse Indigenous Peoples, and we recognize their history, spirituality, culture and stewardship of this land.

We also acknowledge the Chippewas of Georgina Island First Nation as our closest First Nation community.

H.2 Support for Asylum Seekers in York Region

Council adopt the following recommendations in the report dated September 25, 2023 of the Commissioner of Community and Health Services:

- 1. Council authorize funding of up to \$4.3 million within the approved Community and Health Services budget for the Region's assistance with interim accommodations and wrap-around supports to asylum seekers in York Region until March 31, 2024 as described in this report.
- 2. Council authorize the Commissioner of Community and Health Services to execute agreements, as required, to facilitate these supports.
- 3. The Regional Chair send a letter to the Minister of Immigration, Refugees and Citizenship of Canada and the Minister of Municipal Affairs and Housing informing them of these supports and requesting Federal and Provincial funding to fully offset municipal costs.
- 4. Council request the Federal Government to fund and implement a regional response in municipalities in the Greater Toronto and Hamilton area and beyond that will provide coordination for asylum seekers to access adequate shelter and support.
