Housing and Homelessness Committee

Proposed Mandate

Guide development of next 10-year housing and homelessness plan and oversee early stages of implementation, with focus on increasing supply across housing and homelessness system

Responsibilities:

- Identify, prioritize, and recommend housing and homelessness system **solutions** to inform next 10-year housing and homelessness plan
- Support coordination with key partners, such as local municipalities and development industry, to advance shared priorities
- Advocate for investment from all levels of government and support the Region to secure relevant funding
- Monitor and evaluate effectiveness of housing strategies, policies, and programs
- Other responsibilities approved by Council

June 2025	Identify Opportunities: Accelerate housing options, overcome barriers, leverage innovative solutions	 Receive an update on the Regional Lands Highest and Best Use evaluation Receive an updated site selection framework for emergency, transitional, and community housing to recommend for Council's approval Identify strategies to accelerate housing and homelessness projects and priorities
September 2025	Identify Opportunities: Learn from experience and explore a pilot project	 Review direction and implementation of actions to increase affordable and community housing supply Provide feedback on work to advance emergency and transitional housing sites and make recommendations to Council Receive information on barriers, opportunities, and lessons learned from panel Recommend opportunities to leverage \$35.1M Regional investment, with focus on innovative techniques and increasing speed new units can come online (HYI/non-profit development)
October 2025	Moving Forward: Advance a pilot project in York Region	 Receive update on next 10-year housing and homelessness plan Recommend pilot project for Council's consideration from a list of potential options


