#### F.1 Update on Accessibility Activities

Lois Davies, Manager, Social Policy and Accessibility, Strategies and Partnerships Branch, Community and Health Services provided the following updates:

#### F.1.1 Information and Communications Standard

The province has released proposed changes to the legislation and is inviting feedback by October 18, 2019 from individuals and organizations across Ontario. Members of the York Region Accessibility Advisory Committee are encouraged to provide input regarding these proposed changes.

# F.1.2 Greater Toronto and Hamilton Area Accessibility Advisory Committee Joint Sessions

These sessions are hosted by the Toronto Transit Commission's Advisory Committee on Accessible Transit with a view to improve the coordination between service providers in the GTA, resulting in better service. Astley Dennis and Kirsten Hill, members of the York Region Accessibility Advisory Committee have volunteered to represent the committee at these meetings. The next meeting on October 3, 2019 will be hosted by York Region Transit at the Richmond Hill facility, 55 Orlando Avenue.

#### F.1.3 Invitation from East Gwillimbury Accessibility Advisory Committee
